## **OBITUARIES**

#### **LINDA WOOD**



Linda Wood, a long-time softball journalist and former Softball New Zealand staffer, passed away aged 58. Linda was an employee, colleague and friend of the softball community who held administration and media roles within the organisation

between 2006-2013.

Linda began in journalism in the early 1990s as a secondary school's sports correspondent for The Evening Post, the capital city's afternoon daily. She impressed with her enthusiasm and commitment to her craft to earn a staff sport's writer's position. Linda enthusiastically embraced softball as one of her key rounds, developing a deep affinity for the game - both men's and women's softball.

Linda was respected in the sports journalism industry and won the NZ Softball Writer of the Year award in 1996, one of four Post sports writers to win national accolades that year. She remained a proud Post staffer till 2002 when the paper merged with The Dominion. Linda maintained her association with The Dominion Post, covering Wellington and Hutt Valley softball as a 'stringer'.

Linda continued to serve The Dominion Post as a youth sports correspondent and some of the current Black Sox and White Sox players were profiled by her after making national age-group sides. Senior Stuff journalist Richard Ives, who worked alongside Linda in the Wellington sports team, said: "For many years, she covered college sport for the Wellington newspapers, a task she undertook with her trademark diligence and dedication. It could be a challenging role, with schools vying keenly for coverage of their students' success, but Linda showed a knack for highlighting the most notable achievements and with sensitivity and knowledge."

Linda's love of softball manifested in a staff job with Softball New Zealand as office manager from 2006 to 2013, leaving only after an office restructuring.

In more recent years, she worked in various roles, including as a teacher's aide, and remained very proud of her son Jesse's achievements. But she never lost her high regard for our sport, often messaging softball friends about the game's latest developments right up to, and beyond, the recent men's World Cup in Auckland.

#### **ARNIE HALL**

Arnie was a Canterbury softball personality admired by many. A player, a coach and recipient of SNZ Distinguished Service Award.

Arnie Hall – the first Canterbury men's player named in a New Zealand team – was one of the great achievers, contributors and personalities of Christchurch softball. It's fair to say everyone involved in Canterbury softball from the 1940s to 90s – and many further afield - would have a fond memory and a tale to tell of Arnie.

Arnie's passion for the game and his gentlemanly qualities were always uppermost throughout four-plus decades of devoted softball service.

But Arnie couldn't have done all he achieved without the unwavering support of his wife, Shirley, who passed away in December.

Arnold Hall began playing softball for the Richmond club, but he and a group of ballplaying buddies left to start their own club, Ohio, in 1950.

"The players I came up the grades with all wanted to play senior softball together," Arnie explained to The Press in 1974. "But we all couldn't make the top Richmond team, so we formed our own club ... Ohio. We found the name in an atlas."

Arnie was joined at Ohio by Alan Ballantyne – Canterbury's star pitcher of the 1950s to early 60s – Jim Quickenden, Basil Lapthorne, Neville Trueman, and, for a season, Don Lew (another leading Canterbury player of the era). They won the Canterbury championship in their second season season, and all up, took four provincial titles. A left-handed top order batter and athletic shortstop, Arnie was one of Canterbury's best players in the 1950s.

His career highlight came in 1953 when he was named in the New Zealand team to play The Rest after the Beatty Cup interprovincial tournament in Lower Hutt. That earned him the honour of being the first Canterbury man to be selected for New Zealand.

Ohio disbanded in 1957 and Arnie returned to Richmond, who won six Canterbury titles between 1958 and 1965.

By the dawn of the 1960s, Arnie was a family man – he and Shirley, herself a former softballer – had three children, sons Alan and Jimmy and daughter Kerry. That limited his availability for representative softball despite remaining one of the best players in Canterbury. A total enthusiast, Arnie was always keen to see softball develop and that desire prompted another change of clubs in the late 1960s when he left Richmond to coach United.

#### **ROB SIOLO**

Arnie was joined at United by Richmond clubmates Mike Nalepa (a Canterbury catcher), big-hitting Bryan Mountford, who became a gold medalist at the 1976 World Series, and pitcher Dave Bradbury, who should have won the silver fern too in his prime. That gave them a great foundation from which to challenge Richmond and the fast-rising Papanui. Arnie became a leading contributor to United winning their first senior title that season.

He went out a winner at his final big tournament, helping United win the Webb Shield New Zealand United Clubs tournament at Naenae in March 1974 – only the second time they had taken home the trophy. That's when he gave his career-ending interview to Press sports reporter Graham Skellern. Arnie told him he had "always been a believer in the fundamentals of the game" and "don't like to see the basics forgotten". He admitted he had had "a fair innings, and it's time to step down. I regret having to finish but I have to give way to the youth."

While still playing senior ball, Arnie had become a Canterbury selector (a role formerly held by brother Bob) in the early 1970s. He'd been coaching schoolchildren teams for years and became Canterbury B men's team coach in 1975 for a series against Combined Services, guiding a team that included his 16-year-old son Alan on the pitching mound.

Arnie was always an advocate of blooding young players and he had a bunch in his Canterbury team he guided to fifth-equal place at the 1976-77 national tournament in Wellington.

He remained a Canterbury selector with coach Dennis Rea in the late 1970s, but really made his mark on the national scene after he took his United City team across town to join Burnside, formed initially as a women's club by NZSA councilor Lyndsey Leask. Arnie's Burnside boys became the first Canterbury club for many years capable of challenging the North Island elite.

Arnie returned to coaching with Cardinals in the late 80s-early 90s, but in latter years was more content to watch from the sidelines and debate the game's intricacies over a convivial ale in the beer tent. While Arnie was best known as an elite player and coach, he did also serve on the CSA competitions committee and in 1970 helped form the Canterbury Evergreens Club, serving as inaugural secretary alongside other great identities such as Alan Ballantyne, Geoff Griffin, Keith Bingley and Ian Pollock

Highly respected too on the national scene, Arnie was a proud recipient of a Softball New Zealand Distinguished Service Award for his unstinting efforts to develop softball in Canterbury and the South Island.

Rob Siolo was born and bred in Wainuiomata. From a young age he developed a love of sport. He played multiple sports from rugby and league to soccer and athletics, including holding the Javelin record at Parkway College (now Wainuiomata College).



His softball journey did not start until he was 20 where he was invited by a good friend to play a game for Tawa Softball Club. He knew nothing about softball, but his first game saw two hits fly over the outfield changing rooms at Redwood Park. That day ignited a passion that would fuel him a lifetime.

Rob played softball for several clubs spending most of his playing career with Royals Softball Club, Wellington in Premier 1 and 2. After a hiatus from Softball and two children later he decided to pick up Softball again in the early 2000s playing Premier 2 for Royals and coaching his son Zane, who was coming through as a pitcher.

While Rob was still playing softball himself, he simultaneously coached multiple age grade and representative teams ranging from U11s to U19s between Wellington and Hutt Valley Softball Associations.

Following a stint as Tanifa Samoa Softball's assistant coach Rob was appointed head coach to compete in the 2013 ISF World Series in Auckland. Samoa came 7th which included a surprising win over USA, and very close games against Japan and Australia.

His softball journey was to take him to Johnsonville Softball Club where from 2012 to 2020 he was appointed the Premier 1 Men's coach, coaching the likes of Joshua Pettett (multiple capped NZ Black Sox) and Zane Siolo (multiple caps for Tanifa Samoa). In 2018 the Johnsonville men went on to win the Wellington Competition, the first time in the club's history.

Coaches, umpires, and players alike will remember Rob as opinionated and passionate. He placed high standards on himself and expected nothing less of others. At the heart of it Rob wanted his players to reach their full potential and exceed the goals they set themselves.

In 2021, Rob undertook the role of Premier 1 Women's coach with a long-term goal to win both Wellington championships. A strategic thinker Rob always had a well thought out game plan and timeline to bring the best out of the team. A hard task master Rob ran specific skill trainings and worked hard on building an excellent team culture. He instilled an old school type team building exercise using chants. One that stuck with Johnsonville was the chant Leader - "HEY HEY" to which the team will respond "HO"

While Rob was a formidable opponent on the diamond his biggest fight turned out to be a rare immune disorder. In true Rob fashion, when he was told he was terminal he put on his Softball uniform at Mary Potter Hospice and said he wanted to coach 'his girls' one last time. The girls took the win that day and no one was prouder than their coach. In October of 2022, after a two-year battle with ill health, Rob passed away peacefully leaving behind his wife Bobbie and two children Taylor and Zane. Taylor and Zane were both part of the 2022-23 softball season; Taylor as a player and Zane who picked up coaching in honour of his father.

Following Rob's passing, the Johnsonville girls worked hard to keep the team's goal alive, incorporating those key skills and maintaining the team culture Rob set, battling hard throughout the season and regularly could be heard using their signature chant.

The close of the 2022-23 season saw the Johnsonville Premier 1 Women win both Wellington and Intercity competitions, a feat which hadn't been achieved by the club in 10 years. An exciting, emotional, and fitting close to the season and a tribute to their beloved coach.

#### **PAUL RICHARD STOCKFORD**



Paul also fondly known as "Stocky". The name Stocky dates back to his own playing days in the Horowhenua Region along with his other nickname "Rocket" as he was a catcher and simply had a "Rocket". Stocky grew up playing alongside and catching his childhood bestfriends Dave Workman and Mac Tangaroa

(brother of Chubb Tangaroa). Saturdays would be filled with softball as Paul was a Hawkes Bay Softball Association committee member who ran a very successful junior programme for the children of Levin in the mornings and then would go on to coach and play in the local Senior Compittition.

Stocky loved the game, it would be the game he introduced his 5 children to. Through the love of the game and coaching of their father, they all would go on to higher representative honours. Paul Jnr was a non travelling reserve for the NZU19, Kevin represented Great Britain in a number of World Championships, Katrina has represented NZ for over 2 decades, Leah a NFC Champion with the Canterbury Red Hawks and Nopera a Silver Medalist

with the 2014 Junior Black Sox. Softball was a real family affiar, Vienna wife of Stocky would also join the ranks scoring for many teams which lead to her attainning her NZ scorers badge and would score for the 2001 NZU16 team who travelled to Sydney, Australia.

Stocky, did not limit his coaching abilities to his own household or town, he went on to share his expertise with having coached the following, to name a few;

Horowhenua - Horowhenua U15,17 and 19's, Horowhenua Senior Mens
Hawkes Bay-Manawatū - Central Vikings Men - NFC
Wellington - Wellington U19 Boys & NPC Men
Hutt Valley - Hutt Valley U19 Girls, Cardinals Premier
Men, Hutt Valley NFC Men
Canterbury - Halswel Premier Women, Papanui
Premier Women, Canterbury Red Hawks
New Zealand - NZU16 – 2001, NZU19 - Ass Coach,
NZ U19 - Head Coach

When Dave Workman spoke at Paul's tangi he mentioned that the question was never could Stocky have coached the Black Sox, but that the question was, would he have made a difference? Dave's answer was yes, yes he would have made a difference.

#### **JACK ROCHFORD**

Jack first started playing softball in the early to midfifties. After a couple of years playing, Jack became engaged in coaching, both at club and provincial level. He coached the Canterbury Women's team, taking them to 3 inter-provincial tournaments.

About 1958-59 Jack took on full-time umpiring. He received his NZ Badge at the 1960-61 Women's Tournament, under John Reid who was acting as Deputy Chief Umpire.

In the late fifties, the Canterbury Umpires Association was formed by Jack, Jim Gibson, and Morrie Jackson. Alan Lazarus, a NZ Badge holder on transfer from Wellington was also involved, at that time he would be the only NZ Badge holder in Canterbury.

Jack continued umpiring until 1980, attending at least two tournaments each season. A career that had its highs and lows, but always very rewarding and enjoyable. Particular enjoyment was working under Ray Weaver, on the Rules Committee, and officiating as Deputy Chief to Ray at many tournaments. Jack was a member of the Richmond Softball Club - a dedicated stalwart for many years.

# CHAIR & CEO REPORT

#### **HOANI LAMBERT & TONY GILES**

The 2022/23 year was a momentous period for Softball New Zealand as we celebrated the return of our full domestic season and the commencement of international touring for the first time since the pandemic began.

It was exciting to welcome the return of some of the most anticipated events on the grassroots calendar, our age-grade pathways. After a three-year hiatus, the U17 and U19 National Championships took place, as did the National Secondary School Championships.

We also celebrated and supported the inclusion of regionally delivered U15 open events. This reflects positive growth within Balance is Better philosophies that are being championed around the motu.

Following New Zealand age-grade national team events in Australia, the Sky Sport White Sox were the first senior team to travel post-Covid when commencing their Group C World Cup Qualifier preparations with a New South Wales Tour in December.

In November our community celebrated the Tradestaff International Invitation Series in Palmerston North. The first international softball event on New Zealand soil since the WBSC U18 Men's Softball World Cup in 2020 – also in Palmerston North. In a world first, the top 6 ranked men's teams competed in the same event outside of a world cup.

Just one week later, the softballing world had eyes on Rosedale Park for the WBSC Men's Softball World Cup. In another world first, Whakaata Māori partnered Softball New Zealand to deliver the first global indigenous broadcast of a WBSC event. All 50 games across 9 days were delivered with an average daily television audience on Whakaata Māori of over 38,000. The broadcast content was also purchased in 15 countries around the world.

This first and last 12 team World Cup men's edition (8 team event from 2025) showcased the incredible competitiveness and talent of the men's elite game, with both Japan and New Zealand missing the Super-Round.

Softball New Zealand thanks North Harbour Softball Association and the Local Organising Committee, and especially event Co-Chairs Bob Leveloff and Fay Freeman for delivering this world-class event, and for doing so on budget in the most difficult of trading conditions.

February saw the return of the hugely exciting Fastball 45 National League Finals. This high-paced,

energetic, and colourful showcase of modified softball was hosted at Fraser Park. Porirua City United and Papanui Angels took out the Men's and Women's national titles respectively.





In April of this year, we witnessed our Major Sox make the Super-Round at their inaugural WBSC U23 Men's Softball World Cup. After two years of delays and cancellations, this talented young group will be well placed for future success.

In a highlight for many in our community, the return of an in-person Annual Conference and Awards connected members like never before. This 2-day facilitated event shared robust thoughts and outcomes that will help shape the future of the sport in Aotearoa for the next generation.

The Annual Awards celebrated the achievements and service of incredible people within the membership. Congratulations to Suzette Taylor of North Harbour Softball Association for her supreme award.

The year also brought with it moments of reflection, with the passing of Linda Wood, Arnie Hall, Rob Siolo, and Paul Stockford. Our condolences to all members who lost loved ones during this past year.

Despite the significant investment in the World Cup and the men's campaign, Softball New Zealand has the resources to manage its economic impact without damaging the continued and growing investment into the grassroots game.

Since the commencement of 2022, management have been exploring different viewpoints and engaging in important korero regarding the structure of the game in New Zealand, conversations that have not taken place in-depth for well over a decade. The Strengthen and Adapt framework will provide Softball New Zealand the ability to invest in member approved initiatives that support a bigger and more diverse participant base, capable and aligned delivery models, as well as strengthening business outcomes and high-performance success.

In addition, a select committee has been appointed to design, implement, and deliver, an exciting new phase in event delivery from the 24/25 season. Watch this space for the NSL!

Affiliation numbers show actual growth year on year and particularly in Rangatahi with an increase of 9% from the previous reporting period.

We also maintained retention in Tamariki numbers across the motu post-Covid which was particularly pleasing.

Softball New Zealand successes in commercial revenue (+33%) and Class 4 (+52%) over the last year far exceeded expectation post-pandemic. These were largely weighted against world cup deliverables but nonetheless provide optimism in what will be the most arduous and competitive economic environment we have faced in a decade. The loss of long-term commercial partners Golden Homes and Temperzone will be felt by membership, as will the pending departure of Sky Sport from the White Sox programme.

Thank you to Sport NZ, and High-Performance Sport New Zealand, whose continued support enables us to invest in the game's growth and development at all levels. We acknowledge the tremendous support of all Class 4 and commercial partners of softball in New Zealand including Tradestaff, Dynasty, Honda, Resene, and Steve's Tyre Service.

A special mention to our wonderful membership who work tirelessly with and for the community to enhance the lives of whanau through enabling locally-led delivery of the great game of softball.

We owe thanks to the Softball New Zealand Board who have strategically navigated our path post-Covid. Who have had the courage to listen to members, and who will now lead us on a new path together. A tremendous thank you to our national team management and in particular to Mark Sorenson,

who after 10 years at the helm, and a lifetime of dedication and devotion to the sport, has called time on his Black Sox career. We thank you.

To our senior officials, Lil Natana, Wiremu Tamaki, and Lynette Leathart. We thank you and your wonderful crew for the integrity and professionalism you provide each and every game.

Our volunteers across the motu. Your continued mahi and service to softball is invaluable.

Lastly, to the staff at Softball New Zealand. You amaze me every day. It has been a most challenging period and I champion your efforts and dedication in making this organisation stronger.

To Glen Roff, I thank you for 20 years of service. One of the most trusted and loyal members of the softball community. We wish you well with future endeavours.

#### SOFTBALL MANAGER REPORT - GLEN ROFF

Although most of the difficulties and challenges posed by Covid were behind us, the 2022/23 season was far from business as usual. The Tradestaff WBSC Men's Softball World Cup dominated the spotlight, causing other development opportunities and events to take a backseat or be impacted in various ways. Nevertheless, as a sport, we persevered and achieved several successful outcomes by the end of the season.

The second year of the Poiuka Tairawhiti project replicated year one in that it was hugely rewarding with great outcomes for the region. The success of the year two delivery was due to a locally led approach. Ray Noble (Regional Development Manager), and Softball Officers Mike Marumuru and Corev Boocock delivered softball to 713 rangatahi from 16 kura across Tairawhiti from Te Kaha to Matawai targeting high deprivation communities and decile 1 schools. Of the 713 participants (6324 participations) 678 identified as Maori. Over the 6 months of the programme the team coordinated 2 regional tournaments, 4 cluster tournaments whilst delivering every day an in-schools development module for term 3/4 of the school year. To put the icing on the cake the Poiuka Tairawhiti project was recognised by winning the Community Impact Award at the prestigious Sport NZ Sport and Recreation Awards.

After a two-year hiatus, the long-awaited return of the Tradestaff FASTBALL 45® National League Grand Finals took place at Fraser Park, Lower Hutt. In keeping with the game, competing teams delivered an outstanding display of skill, quality and intensity that exceeded the expectations of fans who had eagerly awaited its comeback. FASTBALL 45® rules continue to be applied in various formats across the regions at U13 and U15 school, club, and regional tournaments.

The Strengthen and Adapt project was a significant and critical piece of work undertaken over many months. The initiative is the result of discovery, consultation, and contribution from a range of softball stakeholders including four association forums, two national team forums, focus groups and

one-on-one meetings with selected stakeholders. Two key projects were identified as a result of the research:

- 1. Aligning softball behind a revitalised story
- Increasing understanding, capability, and collaboration to provide quality experiences.



These two areas were selected because they will have the most impact on softball in addressing current and future challenges. These change initiatives align with the One Softball Plan 2019-2029 and focussed on strengthening softball in Aotearoa to prepare for future agility and adaptation.

Playing strength numbers increased 14 teams (1539 to 1553) between the 2021/22 and 2022/23 seasons. Increases in 12+ years (+4), School teams (+34), and Social/Community/Slow pitch (+2).

Other notable game development successes over the last financial year include:

- The launch of the monthly Sox Nation Insider Newsletter
- Updated and improved Mental Skills module to support our developing coaches. 3x practical courses delivered in Albany, Lower Hutt, and Christchurch
- Rollout and pilot of the Regional Development Programme
- Developing Sox Girls U15 Open Clinics -134 registrations across 4 regions
- Female Rangatahi Survey
- Formation of the Balance is Better Advisory Group
- Whangarei Softball becoming a sub association with North Harbour.

#### CHIEF UMPIRE REPORT – WIREMU TAMAKI

It is my privilege to report on the activities of the Softball New Zealand (SNZ) Umpiring Programme for the 2022/2023 season.

Coming off the back of a disruptive Covid-19 year the challenge this season was to support all the events on the softball calendar that led to the Men's World Cup in December 2022. It cannot be understated that it was certainly a season that needed everyone's manaaki and one that no matter what the challenge was, we'd find a way to be successful! Come take a walk with me around the yard to see how we managed.

National Umpire Staff (NUS) – the NUS were represented by Lindsay Edwards, David Beaumont and Nicola Ogier as Deputy Directors, Mark Porteous (Northern), Gavin Shepherd (Central) and Rikki Thompson (Te Waipounamu) as Regional Directors, Kevin Gorman (Northern), Ray Dyason (Central), Dawie Sutton (Te Waipounamu) as Assistant Regional Directors and me.

Other Committees – Dave Beaumont, Dave Fortin and Nicola Ogier made up our Rules Committee. Lindsay Edwards led our Assessment Framework as Alumni Convenor working in tandem with Rikki Thompson. Dave Beaumont led our tournament framework as National Tournament Convenor. Continuing the work in progressing our grading frameworks was Jill Farquhar assisted by Mark Porteous, Gavin Shepherd, and myself. And leading our international rules committee was Mark Porteous with support from Dave Fortin. An additional opportunity saw Mark Porteous and myself lead as WBSCs International Certification Clinics.

**Recognition** – at this year's recognition dinner we recognised and celebrated all the recipients who could not be honoured due to the pandemic. Amongst the lineup we celebrated with Nicola Ogier as the recipient of the SNZ Umpire of the Year, Lindsay Edwards as the 2022 WBSC Hall of Fame recipient and myself for the same honour for 2019.

**Rules Test –** was released in August | September 2022 in two sections – level 1 to 3 and level 4 to 7. The structure of the rules test supported a number of initiatives to ensure those who participated were well equipped to do so. The results were a mixed bag

from the previous season with 44 (73 last year) completing the Level 1-3 test with an average score of 66% (61% last year). Level 4-7 yielded 58 (82 last year) participants with an average score of 79% (73% last year).



We promoted The Chase Rules Test in November 2022 as a significant lead-in to the Men's World Cup to test our communities' rules knowledge and have some fun learning our rules. While the uptake was modest it has factored into our rules practice to test our community now and again!

National Tournaments. The season was jammed packed with the season starting in September to cater for an early National Fastpitch series, a couple of Black Sox events, an international lead-in tournament to tie into the Men's Worlds in December. It was certainly a very busy time for our umpiring team providing a number of first opportunities for all. Following those tournaments were our age grades and opens which saw the season round out with the Secondary Schools in March. I can say without a doubt that there was no time to rest. It was certainly a 'muck-in' for everyone and mahia te mahi!

# Our Strategy: Mahere Rautaki

## Our Vision: Whakakitenga

We want softball to be a sport for life. One that evolves as it needs to, is enjoyed by all those who connect with the game in any capacity and is characterised by success.

#### Our Collective Purpose: He Kaupapa

We are all tasked with working together to enable Kiwis to participate in softball in whatever way they choose and to have a great time doing so to ensure that they stay involved and get the best experiences from the game.

# Our Approach: Nga Huarahi Mahi

To be successful we will need to:

- Focus on the needs of the people wanting to be in our game and work hard to meet these
- Open to change and doing things differently.
- Inclusive.
- Play to our strengths.
- Work together.

#### Our Strategic Framework: Pou Tarawaho

We have four strategic outcomes which, if we can progress towards, will help us to achieve our vision. These are:

- 1. A bigger, more diverse participant base
- 2. Capable, aligned and consistent delivery
- 3. Strengthen the business of softball
- 4. High performance success

## 1. A Bigger More Diverse Participant Base

We will focus on meeting the needs of our whanau and the people wanting to be involved in our game. This is about taking a participant-centred approach to planning and decision-making where the participant may be a player, coach, umpire, scorer, administrator, supporter, sponsor or funder.

Today, our communities are increasingly diverse and as a sport we must respond by finding ways to make softball a game for all ages, abilities, genders, and ethnicities.

Having had a disrupted experience in recent years due to COVID, we have the opportunity to learn from recent changes and apply them to align our delivery model in a way that offers both regional participation and national performance through a facilitated regional and national delivery model.

#### **Success factors**

- Growth in targeted areas of rangatahi, women and girls <u>2023</u> 56 female teams competing at the age-grade events (19 Girls and U17 Girls), NFC, Open Womens Clubs and Secondary School Div 1 & Div 2 events (Fastball 45 excluded). (<u>2022</u> no events held as cancelled due to covid).
- Introduce a programme to raise cultural understanding and improve application of te reo, tikanga and kawa <u>2023</u> Completion of phase 2 of Te Tairawhiti High Deprivation Cohort programme from 1/7/22 to 31/12/22 with tangible and quantifiable metrics. (Sport New Zealand category finalist and winner of the Community Impact Award for 2022). (<u>2022</u> phase 1 of Te Tairawhiti High Deprivation Cohort programme).



#### 2. Capable Aligned, and Consistent Delivery

We are open to change and doing things differently. In today's sporting environment our success is built around our ability to adapt to changing situations and circumstances. Whatever made softball successful in the past won't necessarily make it successful in the future. At the heart of this is being open to new ideas and information and trying different ways of responding in order to make continuous progress and improvements.

#### **Success factors**

- 1. Initiate the Strength and Adapt Programme with a view to strengthening our support to Associations and Hubs to become operational <u>2023</u> Developed the Softball NZ Strengthen and Adapt plan with identified priorities confirmed and presented and reinforced at the Annual Conference. (<u>2022</u> facilitated consultation with members underway).
- 2. Deliver a capable conference programme at the AGM <u>2023</u> Virtual AGM completed in August 2022 and 2 day Annual Conference held in April 2023 in Wellington. (<u>2022</u> Virtual AGM completed in August 2021. No annual conference).

#### 3. Strengthen the Business of Softball

The business of softball has both an internal and external perspective. On one hand it is about the financial sustainability of softball organisations brought about through different softball activities and on the other it is about the quality of our relationships with funders and key commercial partners. When we are seen to be capable organisations that run in a sound business-like manner with viable products and opportunities, we are better placed to develop long-term and successful commercial and funding relationships because we can deliver value. This is relevant at all levels of our game.

## Success factors

- 1. Deliver budget <u>2023</u> Delivered against Budget deficit of (\$89,786) with actual deficit of (\$101,816). (**2022** Delivered against Budget decifit of (\$59,620) with actual surplus of \$132,677).
- 2. Increase number of commercial partnerships <u>2023</u> increased commercial partners (to value in 2023 of \$366,843). (**2022** \$275,221).
- 3. Secure Grant Funding <u>2023</u> increased grant funding support (to value in 2023 of \$381,969). (2022 \$250,227).

#### 4. High performance success

Remaining competitive and winning is challenging and reliant on good development systems, a deep understanding of what high performance means and having the best people in the right places. Success at this level creates profile for the game from which we can build other activities that enhance the game at other levels. High performance success is supported by quality domestic competitions, a talent pathway that provides a pipeline of talent into the high-performance environment, quality venues and facilities for hosting international events that allow our teams to compete at home, and media support to take the game to the wider population.

#### **Success factors**

- Prepare Black Sox to be best positioned for the 2022 Mens World Cup <u>2023</u> Series of domestically based events and training blocks as build up to 2022 Men's Softball World Cup (Black Sox Trial in October 2022, Black Sox Invitational Club Challenge in November 2022, International Invitational Series in Palmerston North in November 2022, Men's Softball World Cup in North Harbour in November/December 2022 which Black Sox placed 8<sup>th</sup>). (<u>2022</u> N/A).
- 2. Deliver international level event, domestically for the White Sox programme <u>2023</u> Not held (as was still covid impacted). (2022 not held).

## 1 Reporting entity

The financial statements have been prepared in accordance with Generally Accepted Accounting Practice in New Zealand ("NZ GAAP"). They comply with Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") and other applicable financial reporting standards as appropriate that have been authorised for use by the External Reporting Board for Not-For-Profit entities. For the purposes of complying with NZ GAAP, SNZ is a public benefit not-for-profit entity and is eligible to apply Tier 2 Not-For-Profit PBE IPSAS on the basis that it does not have public accountability and it is not defined as large.

Financial statements for the year ended 31 May 2023 presented by the Board of Directors have been prepared under Tier 2 Not-For-Profit PBE Accounting Standards and in doing so has taken advantage of all applicable Reduced Disclosure Regime ("RDR") disclosure concessions.

## 3 Summary of accounting policies

The significant accounting policies used in the preparation of these financial statements as set out below have been applied consistently to both years presented in these financial statements.

#### 3.1 Basis of measurement

These financial statements have been prepared on the basis of historical cost, as modified by the fair value measurement of non-derivative financial instruments and land and buildings which are measured at fair value.



#### 3.2 Functional and presentational currency

The financial statements are presented in New Zealand dollars (\$), which is the functional currency. All financial information presented in New Zealand dollars has been rounded to the nearest dollar.

#### 3.3 Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The following specific recognition criteria must be met before revenue is recognised.

#### Revenue from non-exchange transactions

#### Grant Revenue

Grant revenue includes grants given by other charitable organisations, philanthropic organisations and businesses. Grant revenue is recognised when the conditions attached to the grant has been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability where a use or return condition exists and released to revenue as the conditions are fulfilled.

#### Revenue from exchange transactions

#### Membership fees

Capitation Fees are recorded as revenue when the cash is received. Capitation Fees were due in February based on team playing numbers for the season as per the Certificate of Playing Strength received.

Tour and camp levies are initially recorded as revenue in advance, and then recognised proportionally on the basis of the value of each session relative to the total value of the purchased services.

#### Event revenue

Entrance fees for functions and events are recorded as revenue when the function or event takes place.

#### Interest and dividend revenue

Interest revenue is recognised as it accrues, using the effective interest method.

## 3.4 Financial Instruments

#### Date of recognition

The Association recognizes a financial asset or a financial liability in the statement of financial position when it becomes a party to the contractual provisions of the instrument in accordance with PBE IPSAS 41 *Financial Instruments*. Purchases or sales of financial assets, recognition, and de-recognition, as applicable, that require delivery of assets within the time frame established by regulation or convention in the marketplace are recognized on the settlement date.

# Initial recognition of financial instruments

Financial instruments are recognized initially at fair value, which is the fair value of the consideration given (in case of an asset) or received (in case of a liability). The Association's initial measurement of financial instruments, except for those classified as FVTPL, includes transaction cost.



#### Financial assets

At initial recognition, the Association classifies its financial assets as follows:

- Fair value through profit or loss (FVTPL)
- Fair value through other comprehensive income (FVTOCI)
- Financial assets measured at amortized cost

The basis of the classification of the Association's financial instruments depends on the following:

- The Association's business model for managing its financial assets; and
- The contractual cash flow characteristics of the financial assets.

#### Financial assets measured at amortized cost

A financial asset shall be classified to be measured at amortized cost if the following conditions were met:

- · The financial asset is held to collect the contractual cash flows; and
- Contractual terms of the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

The Association's bank accounts, accrued interest and term deposits are classified under this category. After initial measurement, these financial assets are subsequently measured at amortized cost using the effective interest method, less allowance for impairment. Amortized cost is calculated by considering any discount or premium on acquisition and fees that are an integral part of the effective interest rate. The Association does not have financial assets classified through Fair value through profit or loss (FVTPL) or Fair value through other comprehensive income (FVTOCI).

#### Financial liabilities

Financial liabilities are classified as measured at amortized cost.

After initial recognition, these financial liabilities are carried at amortized cost, taking into account the impact of applying the effective interest method of amortization (or accretion) for any related premium, discount and any direct attributable transaction cost. Gains or loss on financial liabilities are recognized in profit or loss when the liabilities are derecognized, as well as through the amortization process.

The Association's creditors and accrued expenses, employee entitlements and other current liabilities are classified under this category.

#### 3.5 Cash and cash equivalents

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

#### 3.6 Short term investments

Short term investments comprise term deposits which have a term of greater than three months and therefore do not fall into the category of cash and cash equivalents.

## 3.7 Property, plant and equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Where an asset is acquired through a non-exchange transaction, its cost is measured at its fair value as at the date of acquisition.

Depreciation is charged on a diminishing value basis over the useful life of the asset, except for land and buildings. Land and buildings are not depreciated. Depreciation is charged at rates calculated to allocate the cost or valuation of the asset less any estimated residual value over its remaining useful life:

Office equipment 48%Training equipment 48%

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset.

#### 3.8 Employee benefits

#### Wages, salaries and annual leave

Liabilities for wages and salaries and annual leave are recognised in surplus or deficit during the period in which the employee provided the related services. Liabilities for the associated benefits are measured at the amounts expected to be paid when the liabilities are settled.

#### 3.9 Income Tax

SNZ is exempt from income tax as its purpose is to promote softball for recreation or entertainment of the general public. This exemption is specifically provided by section CW46 of the Income Tax Act 2007.

Goods and services tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST except for receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the Inland Revenue Department is included as part of receivables or payables in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the Inland Revenue Department is classified as part of operating cash flows.

#### 3.10 Equity

Equity is the difference between total assets and total liabilities. Equity is made up of the following components:

#### Accumulated comprehensive revenue and expense

Accumulated comprehensive revenue and expense is accumulated surplus or deficit since its formation, adjusted for transfers to/from specific reserves.

#### International Youth Levy Reserve

This Reserve is used solely for the purpose of assisting Youth Team costs.

#### White Sox Programme Levy Reserve

This Reserve is used solely for the purpose of assisting the White Sox. High Performance funding is not generally available for the White Sox.

#### 4 Significant accounting judgements, estimates and assumptions

The preparation of these financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

## **Judgements**

In the process of applying accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements:



#### Operating lease commitments

SNZ has entered into a number of vehicle leases.

It has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a substantial portion of the economic life of the vehicles, that it does not retain all the significant risks and rewards of ownership of these properties and accounts for the contracts as operating leases.

#### **Estimates and assumptions**

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below. SNZ based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising beyond the control of SNZ. Such changes are reflected in the assumptions when they occur.

#### Useful lives and residual values

The useful lives and residual values of assets are assessed using the following indicators to determine potential future use and value from disposal:

- The condition of the asset
- The nature of the asset, its susceptibility and adaptability to changes in technology and processes
- The nature of the processes in which the asset is deployed
- Availability of funding to replace the asset
- Changes in the market in relation to the asset

The estimated useful lives of the asset classes held are listed in Note 3.6.
